Equal Rights Amendment

THE ALICE PAUL EQUAL RIGHTS AMENDMENT:

Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.

BPW/OH's Legislation Platform Preamble: The Alice Paul Equal Rights Amendment shall stand first, foremost and above all other items which may appear on the Legislative Platform of this Federation until equal rights for women and men become guaranteed in the United States Constitution

Reproductive Choice

On June 24th the Supreme Court ruled that the constitution does not provide a right to abortion. The ruling in Dobbs v. Jackson Women's Health Organization allows states to regulate abortion and state legislatures can pass laws that restrict abortion before viability. On the same day, a federal judge lifted an injunction on Ohio's heart beat bill which was signed into law in 2019.

In short, Ohio has banned abortions at approximately six weeks gestation. If any cardiac activity is detected, abortion is prohibited except when there is serious risk of death or substantial impairment of a major bodily function. The bill makes no exceptions for rape or incest.
