The January bitter cold has left many of us with cabin fever. I used my free time to more research on one of my childhood heroes, Dr. Martin Luther King, Jr.. Did you know that he was not born with that name? He was christened as Michael King Jr. in Atlanta Georgia in January 1929. His father so admired the Baptist teachings of Martin Luther that he changed both of their names to Martin Luther Senior and Junior. He was a skeptic most of his youth about the teachings of Christianity but eventually came to believe that many of the teachings in the Bible were true and decided to enter Seminary. He was a voracious student and skipped 2 grades. At 15 he took an entrance test for Morehouse College and was accepted. At 18 he went into the ministry as he had made peace with the Baptist Church and was heeding his inner self to project his rational sermons that were "a respectful force for ideas, even social protest".

Dr. King graduated from Morehouse and enrolled in Seminary in Pennsylvania and graduated from there in 1951. His education was impressive and even after marriage to Coretta Scott in 1953 continued his studies for his Doctorate in Theology at Boston University. At age 25 he received his first church in Montgomery Alabama.

The Busing situation was tense in Montgomery especially after Rosa Parks refused to give up her seat which all led to a 385 day long bus boycott organized by King and then President Nixon. King's home was bombed and he was arrested and the trial led eventually to a trial which ended the racial segregation on all Mont-

gomery buses. This launched King into the national limelight. He was known from then on as the foremost speaker on civil rights.

He then began a very turbulent period of protesting, ministering, jail time, peaceful marches including the Selma, Alabama "Bloody Sunday March".

1963 was the peaceful march on Washington where King gave his famous, "I Have a Dream" speech." That speech is considered to be one of the finest speeches ever given.

He continued to fight the racial injustices in the South in particular but also had a presence in Chicago and spoke often against the Vietnam War.

In 1968 we all know what happened on April 4<sup>th</sup> in Memphis, Tennessee. James Earl Ray shot Dr. King on a balcony of his hotel. Jesse Jackson was there and witnessed Dr. King's shooting.

I remember the shooting and once again our nation was paralyzed by an unreal hush and shock. Everyone was shocked by the event and death of such a great peaceful man, a minister, a man of God. I was only 14 but remember all the television channels (all 3 of them) were obsessed with the story. His legacy still resonates for all of us especially this year, this 50<sup>th</sup> anniversary of his death.

Days after his death, Congress passed the Civil Rights Act of 1968 which is attributed to Dr. King's efforts and his influence has been felt worldwide. His influence will continue for many years in the future.

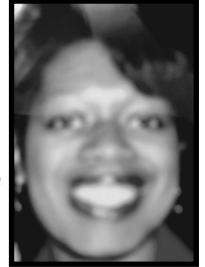

Women Moving History Forward

Hello Volcanoes Out There! Since the year 2017 has ended, what goals does each local have to keep the lava of inspiration, impact and influence flowing to fortify Ohio Business and Professional Women?



First of all, regarding membership we must passionately think positive. No matter how the situation may appear (drop in numbers), there are women in need of our nurturing which can come in the form of coaching or mentoring. When seeking potential members, we must position ourselves to “scope out” their talents and abilities as we are making the effort to promote the organization.

The key to “scoping out” certain talents and abilities is to find out what they like to do, their profession, their passion, what makes their heart sing, etc. Developing a spirit of nurturing is the best way to “scope out” potential coaches and mentors. As a result of our support, reciprocally, they can discover how they can contribute to the organization while holistically continuing the tradition of women helping women. To emphasize these methods:

**Coaching** –is what I see as the semi- retired, retiree someone with a plethora of professional knowledge. Maybe that person does not necessarily want to join an organization, but would not mind coaching on a “short term” basis someone who wants to enter the Young Careerist program or facilitate an Individual Development course. Once the coach sees how they are impacting the next generation of young women leaders, they may eventually join.

**Mentoring**- Although mentors utilize coaching skills to serve the mentee, mentoring involves additional tasks, which can include:

Being a role model—literally displaying the specific actions and behaviors that are role specific

Consulting—sharing information about the industry, company or business unit that mentor believes is relevant to mentee

Brokering—making introductions to powerful, influential, and otherwise useful individuals in the industry or organization

Advocating—for mentee’s work assignments or career development to support the mentee's growth and development.

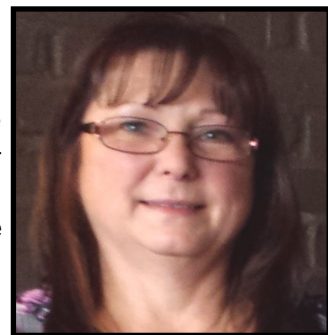
