FROM THE PRESIDENT'S PEN

I challenge you this year to be innovative.

Our theme in this issue of the OBW is Advocate. The dictionary tells us the who and what an advocate does. As we move forward, we need to take stock of our personal commitment to our Legislative Platform and to each other and ask ourselves why, how, and at what cost are we willing to advocate for our Legislative Platform, ourselves, and each other. Are we acknowledging all women's worth, dignity, and value as human beings in our efforts to secure the Equal Rights Amendment, equity and equality in the workplace, etc.? Can we look others in the eye and reflect their value back to them? Do we guide and encourage and not judge or criticize? Do we make others feel like they have been heard that they are valued, and understood? Supporting them in working through their challenges. Do we have belief in our potential and that of others? #### 2020-2021 BPW/OHIO Legislative Platform

#### Preamble

The Alice Paul Equal Rights Amendment shall stand first, foremost and above all other items which may appear on the Legislative Platform of this Federation until equal rights for women and men become guaranteed in the United States Constitution.

The Alice Paul Equal Rights Amendment Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.

## Civil Rights

Actively work to pass legislation, which will ensure equal rights and remedies for women in all phases of their lives, including support of affirmative action programs; and eliminate all forms of harassment against individuals.

## **Economic Equity**

Actively work to support equal educational opportunities; equal treatment for women in all areas of employment, including adequate retirement benefits, improved programs for women re-entering the workforce, and implementation of equal pay for work of comparable worth.

### Dependent Care

Actively work to strengthen and improve enrichment programs, physical facilities and funding for affordable, quality dependent care of all ages.

#### **Victim Rights**

Actively work to strengthen and enforce legal protection for all individuals who are victims of violent acts including domestic and/or sexual violence; promote violence prevention programs; support services and facilities for survivors of this violence and the funding thereof; and support legislation, which provides compensatory and punitive damage awards to victims.

#### Health

Actively work to strengthen and enforce legal protection for full access to all health care services including reproductive choice, funding for research into and protection of women's health care and educational programs concerning women's health issues.

## **Policy Items**

Actively work for the election of and appointment to policy-making positions those who support the BPW Legislative Platform.

## THERE IS NO EQUAL PAY WITHOUT THE ERA

Equal Rights Amendment: Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.

July 17 was the 83<sup>rd</sup> Anniversary of BPW endorsing the ERA.

The House voted on February 13<sup>th</sup> to remove the deadline for the ratification

of the ERA. This vote came 100 years after women won the right to vote and when the amendment was first introduced. It has been 48 years since Congress first approved the E.R.A. in 1972, setting a deadline of 1979 for ratification and then to 1982. But that deadline, too, passed with just 35 states three short of the required 38.

Ohio ratified the amendment in 1974 making it the 33<sup>rd</sup> state to ratify. Nevada voted to ratify the amendment in 2017, followed by Illinois in 2018 and last month, Virginia became the 38th state,

which prompted the move to eliminate the deadline extension.

The House Joint Resolution 79 passed by a vote of 232-183, almost entirely along party lines.

The Bill does have bipartisan backing in the Senate, where it is sponsored by Senators Lisa Murkowski, Republican of Alaska, and Ben Cardin, Democrat of Maryland. Senator Sherrod Brown is a cosponsor, but Senator Rob Portman is not.

to voice your appreciation for their vote along with Senator Brown (all Democratic Ohio house members voted yes) or voice your disappointment (all Republican Ohio house members voted no). Contact Senator Portman and ask him to co-sponsor and vote for removing the deadline for the ratification of the ERA. The companion bill is Senate Joint Resolution 6. Also, a lawsuit was filed in Massachusetts arguing that the US Archivist failed to perform his job to record the 38<sup>th</sup> state ratification. The court date was late June. Interesting, both attorneys and the judge were female. The judge has yet to rule on

In regard to EQUAL PAY — A federal



judge dismissed the equal pay claims of the World Cup-winning women's national team on May 1st. This four year lawsuit had affected the federation's reputation, embarrassed its leaders, angered its sponsors and threatened its financial future, the judge's ruling granting summary judgment in its favor in relation to equal pay arguments. For years, the players have argued that they are paid less than their counterparts on the men's national team. Over and over, they made the case that they deserved equal pay. The judge told them they were wrong. Not only had U.S. Soccer not paid the players less than the men, Judge Klausner wrote, it had convinced him "the WNT (Women's National



Team) has been paid more on both a cumulative and an average per-game basis than the MNT (Men's National Team)" over the years covered in the case. The evidence the players' lawyers presented to counter the federation's math, he concluded, "is insufficient to create a genuine issue of material fact for trial. In effect, he said, they could never win. A trial for the remaining portions of the lawsuit, which include allegations of differences in men's and women's travel and hotel accommodations, is set to

> begin in June. Team co-captain Megan Rapinoe tweeted: "We will never stop fighting for **EQUALITY."**

You will need to print off the generated form and add any additional information required (like the last 4 digits of your SSN or Ohio driver's license number) and then mail it in. You will then be sent the appropriate ballot to complete

and return before November 3<sup>rd</sup>.

## August 26<sup>th</sup> will be the 100<sup>th</sup> anniversary of women getting the right to vote.

Make sure you exercise your right to vote along with all the women you know. Consider working with the Board of Elections in your area. With absentee voting, they will need extra help.

My responsibilities included writing checks, making deposits, reconciling accounts and preparing spreadsheets for their boards of directors.

Most of my experience has been with non-profit, member organizations. Over the years, the one thing I have learned is that is to keep it simple, so that members do not have to be an accountant to understand their finances.

## Guest Editorial, Dr. Anita P. Jackson, PhD, LPCC "BEING READY FOR CHANGE ON RACISM IN THE U.S."



The past three months have been truly trying for everyone. Fear, uncertainty, frustration, new

ways of functioning with one another, challenges in obtaining the necessities are now all a different reality for us.

If that is not stressful enough, the pandemic is a reminder of the numerous economic, health and educational disparities in our society that result in Black people being more vulnerable to this virus. Now with the death of George Floyd, comes an additional level of emotions and concerns. Some moments, my eyes are filled with tears. Sometimes I swell with anger. Sometimes I ponder

what action for change should I take. Then sometimes I feel like I'm falling off a cliff, unsure of what to do next. I am saddened and feel so much pain right now. I have spoken to so many others who feel the same way.

remember worked with others during the 1960s Civil Rights Movement trying to make our voice loud and clear. Twenty years later when my children entered college, I went to a meeting that one of them attended on campus and was hit with the reality that students of color were struggling on campus with the same issues generation ad-

dressed. The same old racism. The same old police brutality. The same disgusting attitudes and policies of oppression that were evident.

That really hurt and driving home I cried

while thinking that not much had changed. It hurts even more now as I watch my grandchildren facing some of the same oppressive attitudes and policies. It hurts even more as I think of what my parents had to contend with. Four generations just in my life time. It hurts when white people avoid, ignore, are clueless and do not want to deal with the issues of racism that are at play each and every day. It hurts. I'm tired. Black folks are tired.

Some may remember my article on the U.S. paradox. The declaration of freedom for all and the establishment of institutional slavery during the nation's beginnings. A foundation in the development of the United States was racist. Until all people recognize, in a country that professes freedom and equality, that the underlying core of U.S. policy has

Looting and destroying does absolutely nothing to bring healing to our nation and peace within ourselves. We are all hurting now. Why enact more hurt? Tweeting words of divisiveness and insult does nothing to bring healing to our nation and peace within ourselves. We are all hurting now. Why enact more hurt?

Most importantly, we must begin with knowledge that enables all to become socially and politically astute. This requires discussion and challenges for self-reflection within those discussions. Let this be the time of significant change for a 400-year futile oppressive system that was built on a racist ideology. It is way past time to discuss it and implement training in attitudes, knowledge, and skills to bring an end to it.

Can you imagine turning away people who want to join? Now...in 2020? There may be a lesson in there somewhere---if something is too easy or free, maybe it has no value.

Fast forward almost thirty-six years. Many of these people have passed on but I've got to tell you, I remember them

as if they were sitting here with me. What they did, or said, still sticks with me. I think it's called being part of history.

Certainly we want more members, more diversity, and more inclusion. But for right now, let's pause and celebrate 100 years of life. I'm recalling a passage from the Stacey Abrams book: "If you see a turtle sitting on a fence post, you know" she "didn't get there alone. Someone had to pick" her "up and put" her "there."

I can really relate that passage to my BPW experience...that...and overall I've learned again and again that there is nothing more glorious than being heard, understood, and validated---except---helping someone else be heard, understood, and validated!

On August 26<sup>th</sup> we celebrate Wom-

en's Equality Day in the United States that commemorates the 1920 adoption of the Nineteenth Amendment (Amendment XIX) to the United States Constitution, which prohibits the states and the federal government from denying the right to vote to citizens of the United States on the basis of sex.


The 19th Amendment gave women the right to vote nationally on August 18, 1920, but it was not official until it was certified by the U.S. Secretary of State on August 26h. The proclamation was signed behind closed doors at 8 a.m. by the Secretary at his own house in Washington, D.C,

**100 YEARS** — started a century earlier.

In 1971, Representative Bella Abzug championed a bill in the U.S. Congress to designate August 26 as "Women's Equality Day." The bill says that "the President is authorized and requested to issue a proclamation annually in commemoration of that day in 1920, on which the women of America were first given the right to vote."

We could donate to a campaign, put up signs, canvas geographic areas, make phone calls—help women candidates running for office. But, how do we get YOUNG WOMEN interested in, knowledgeable about and motivated to move forward with a career in public office?

Here are two ideas, places to start.

**RUTGERS EAGLETON INSTITUTE OF POLI-**TICS "CENTER FOR AMERICAN WOMEN AND POLITICS" (CAWP) - Ready to Run® program

Introduce young women to CAWP and Ready to Run®, a national network of nonpartisan campaign training programs committed to electing more women to public office.

Per the CAWP website, "research shows that women make government more transparent, inclusive and accessible. Women bring different priorities and experiences to public life, including perspectives that have been largely absent in public policymaking. Women change the way government works, and their voices are needed around the country. Ready to Run® is a non-partisan campaign training program to encourage women to run for elective office, position themselves for appointive office, work on a campaign, or get involved in public life in other ways. CAWP's model curriculum covers fundraising, positioning oneself for elected office, navigating the political party structure, media training, the nuts and bolts of organizing a campaign, mobilizing voters, and crafting a message".

as self-governing citizens by informing Many BPW locals across the state of Ohio them about the duties, privileges, rights and responsibilities of American citizenship and hopefully encourages their participation in the democratic process as they progress into adulthood.
