Add another one to the list. The 94th Annual BPW/OHIO State Conference was successfully held in Strongsville over 2 ½ days in mid May. Seventy-nine (79) BPW mem-

bers attended, 12 Past Presidents, 21 Vendors, 5 Seminar presenters and 6 Speakers!!

Friday opened with two morning seminars; "The Wild World of Communication: How to Advance as a Professional, Lead, Influence and Keep Your Cool" and "Why Did I Come in Here? Alzheimer's Disease, What You Need to Know." Lunch with Barbara Williams, Executive Director of the International Women's Air & Space Museum took us through the history of her career as the first women in many jobs with the FAA. The third seminar of the day "How Safe Do You Feel? Personal Protection" followed lunch. The business of BPW/OHIO was conducted at the Board meeting prior to the First Timers Event. This conference had 14 First Timers in attendance! Dinner featured Jodi Scheetz from A.L.I.V.E. Inc. Jodi shared what the A.L.I.V.E. shelter provides to residents of the Steubenville area and BPW learned how to be involved within our local areas. Kitchen items were donated on behalf of all BPW/OHIO members. President Riccadonna opened the Business Session calling on the American Legion Auxiliary Unit 91 to post the colors. We heard a wonderful rendition of the National Anthem sung by a member of the Auxiliary Color Guard. A donation was made to the American Legion Auxiliary. Keynote Speaker, Dr Laura Meeks educated and entertained while telling her journey to the President of Eastern Gateway Community College. She also let us in on the fact that she likes glitz and shoes. The Candidates' Forum was held and the 2014-2015 State Officers were elected. The evening was capped off with the Bling Bash. We socialized and played the game of jewelry stealing. A few ladies had their jewelry snatched away numerous times!

Saturday breakfast hosted the Vendor Fair. Twenty-one vendors presented a 30 second commercial to the members and then we had time to shop. We attended two seminars prior to lunch, "Healthy Cooking" and "Making Office Politics Work for You". Spark the Fire Within owner Diane Quimper gave real life experience to a few members to break through barriers by participating in Arrow Breaking and the Glass Walk. The Second Business Session took place; awards were presented, business was conducted and we heard from two speakers. Colleen Byers, Berea BPW member shared her tale of working on Hillary Clinton's Presidential Campaign in Iowa. She shared how small town USA conducts political business --- where everyone knows your name! Ohio House District 13 State Representative Nickie J Antonio spoke about how she came to be in politics and what she is involved with at the State House. Mary Clark, Chillicothe BPW member gave a heartfelt remembrance of PSP Kathy Wilson. Dinner began with Carol Ater, Chillicothe BPW being announced as the Joyce M Davis Distinguished Member recipient. Both the Individual Development and Young Careerist speeches were presented. Incoming President Kathy Kellums, the 2014-2015 Executive Committee and Board of Directors were installed. Once out of our fancy clothes and into comfy clothes we mingled at the celebrations for Kathy and Leona. Let it be known that a group of BPW members were deemed too loud by the hotel and the police had to be sent to the room. The Individual Development Program (ID) provides training and practice opportunities in public speaking, general communications and job performance skills. It introduces participants to the mission and vision of Business and Professional Women (BPW)

The program consists of two parts:

The **FIRST PART** is facilitator led training of 14 modules and will take approximately 14-16 hours of time. The **SECOND PART** of the program involves selection of an ID representative to represent BPW/OHIO. The participation for a <u>local is not limited to one Individual Development candidate</u> to participate in the Region ID Competition. Each local may send <u>more than one candidate</u> to their Region competition; however, in order to compete at the Region level, each candidate must be a BPW member.

At the Region competition, one candidate will be selected to represent that Region at the BPW/OHIO Individual Development Speak-off at the BPW/OHIO Leadership Training on April 11th 2015. The participant selected to represent BPW/OHIO will be given the opportunity to present their speech at the State Conference on May 16th 2015 at the Crown Plaza North in Columbus.

Contact your Region Individual Development Chair for the course sessions scheduled for your Region. Locals and Regions can offer any combination of the modules for their class sessions. Please understand, to compete in the Speak-off in April 2015 the individual must have completed all 14 modules sometime in the three-year period before the Speak-off competition (2012-2015).

Documentation needed to compete in the Region and State Speak-offs as well as informational items are on the BPW/OHIO website <u>bpwohio.com</u>.

OHIO FEDERATION OF BUSINESS AND PROFESSIONAL WOMEN RESOLUTION 1 – ALICE PAUL EQUAL RIGHTS AMENDMENT

WHEREAS, in 1923, at the celebration of the 75th anniversary of the 1848 Women's Rights Convention, Alice Paul first introduced her "Lucretia Mott Amendment" which she proposed to have added to the Constitution of the United States, and which read, "Men and women shall have equal rights throughout the United States and every place subject to its jurisdiction;" and

WHEREAS, in 1943, Alice Paul rewrote the amendment to reflect the 15th and 19th Amendments to that same Constitution, so the Equal Rights Amendment, now known as the "Alice Paul Amendment" stated, " Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex;" and

WHEREAS, the Equal Rights Amendment (ERA) was reintroduced, and continues to be reintroduced in Congress each year, but has not yet received passage by two-thirds vote of each house of Congress and ratification by 38 states so that it may be added to the Constitution of the United States; and

WHEREAS, the Equal Rights Amendment reminds us that there is still much work to be done to ensure that women enjoy equal rights and the benefits of the same in the workplace; and

WHEREAS, the conference body of the 94th annual state conference of BPW/OHIO adopted the 2013 - 2014 Legislative Platform, which, in its preamble states, "The Alice Paul Equal Rights Amendment shall stand first, foremost and above all other items which may appear on the Legislative Platform of this Federation until equal rights for women and men become guaranteed in the United States Constitution;"

THEREFORE, BE IT RESOLVED, that each BPW/OHIO member be encouraged to support those political candidates who share the ideals expressed in the both the Federation's Legislative Platform and the ERA, and who will work to enact laws that incorporate the same; and

BE IT FURTHER RESOLVED, that each local BPW organization be encouraged to remember those sisters who have gone before us, seeking equal rights under the law, and encouraged to address and commemorate the issue of equal rights in at least one meeting or activity during the coming federation year; and

BE IT FURTHER RESOLVED that this resolution be published in the next issue of the *Ohio Business Woman*.

WHEREAS, the members of BPW/OHIO can directly influence the outcome of this election by their respective votes and the support of those candidates who, in turn, support the legislative platform adopted by this convention body and the issues working women hold near and dear and which daily impact their place in the workforce and in their personal lives; and

WHEREAS, each voice and each vote counts;

THEREFORE, BE IT RESOLVED, that BPW members be encouraged to become informed about issues and candidates that will appear on the ballot, and that they be further encouraged to vote and that they encourage others to vote on election day 2014 and in all subsequent elections; and

BE IT FURTHER RESOLVED THAT this resolution be published in the next edition of the *Ohio Business Woman*.

Region 4 locals did not apply;

Region 5, Chillicothe BPW, Tiffin Towers, for the replacement of some computers;

Region 6, Lebanon BPW, Station Hill Senior Housing, - fresh farmers' market foods.

Women's Retirement Foundation is supported by your donations – the Grants are designed to provide support to the elderly population in your community. Do not wait, choose your qualified facility and complete the application now. Don't miss this opportunity to support your community through your BPW local. The application form and other material are on the BPW/OHIO website. This material will also be sent to each local president.

In addition to the Grants, BPW/Ohio Women's Retirement Foundation provides State Training Nursing Assistant scholarships. Since STNA training sessions are held at various times during the year throughout the state of Ohio, the Board has approved four (4) Quarterly \$500 scholarship awards.
