## Equal Rights Amendment

### *The Equal Rights Amendment*

**Section 1.** Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.

**Section 2.** The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

**Section 3.** This amendment shall take effect two years after the date of ratification.

The Equal Rights Amendment was drafted in 1923 by well-known women's rights activist Alice Paul. It was first introduced in Congress on December 13 by Representative Daniel Anthony (R-KS), who was suffragette Susan B. Anthony's nephew. The debate over the ERA continued for decades, and the ERA was reintroduced in every Congress until 1972.

By March 1972 the ERA had been approved by 2/3 vote of both houses of Congress and was sent to the states for ratification. Twenty-two states quickly ratified



the amendment in 1972. But when the final deadline for ratification arrived in 1982, the constitutionally required number

of ratifications—3/4 of the states—had not been attained. Only 35 states ratified out of the 38 required to put it into the Constitution.

In 1978, Congress clearly demonstrated its belief that it may alter a time limit in the proposing clause when it passed an extension of the original seven-year limit for ERA ratification and moved the deadline from March 22, 1979, to June 30, 1982. If the time limit had been placed in the text of the

amendment itself that restriction would not be subject to alteration by Congress after any state legislature had ratified. Still to this day there are 15 un-ratified states.

The ERA has been introduced into every Congress since 1982.

Beginning in 1994 with introduction of the first "Three-state strategy" legislation in Congress, ERA advocates have been pursuing two different routes to ratification:

- the traditional process of 2/3rds majority and the 38 states ratifying
- removing the time limit on the ERA's ratification process and ratify 3 of the 15 state legislatures that did not ratify the ERA during the 1972-1982 campaign

Bills for ERA ratification by traditional amendment process per Article V of the Constitution

- **SJ Res 16** (lead sponsor, Senator Robert Menendez, D-NJ)
- **HJ Res 52** (lead sponsor, Representative Carolyn Maloney, D-NY)

Bills removing the ERA ratification time limit *ex post facto*

- **SJ Res 15** - (lead sponsor, Senator Benjamin Cardin, D-MD) Senate bipartisan bill to eliminate the ratification deadline is gaining support
- **HJ Res 51**- (lead sponsor, Representative Jackie Speier, D CA)

In 2001, a survey showed that 96% of U.S. adults believe that male and female citizens should have equal rights.

A 2012 survey found that 91% of Americans believe men and women should have equal rights affirmed by the Constitution. However, 72% of the people responding mistakenly believed that the Constitution already includes such a guarantee.



## National Business Women's Week

National Business Women's Week was first observed April 15-22, 1928. Lena Madesin Phillips, the president of the National Federation of Business and Professional Women's Club, nationally broadcasted a speech declaring NBWW to "focus public attention upon a better business woman for a better business world".

She acknowledged the challenges that faced America's working women. The idea of a National Business Women's Week is attributed to Emma Dot Partridge who was the Executive Secretary for the National Federation of Business and Professional Women's Club from 1924-1927.

Since 1938, National Business Women's Week has officially been celebrated the third full week in October of each year. We continue to recognize women in the United States who have been successful working women. It wasn't until 1974 that the Equal Credit Opportunity Act guaranteed women access to credit cards and loans. Before this, single women were routinely denied credit, and married women had to take out loans under their husbands' names. The Women's Business Ownership Act of 1988

made the requirement of a male signature illegal, it created the National Women's Business Council, the Office of Women's Business Ownership and inspired the development of Women's Business Centers around the country. BPW Foundation supporters were on the front line in the fight for better conditions and helped open doors for working women.



President Herbert Hoover was the first president to issue a letter recognizing NBWW and the contributions and achievements of working women. And every

president since President Hoover has also issued a message during NBWW celebrating the important contributions made by working women to our economy.



NBWW encourages us to call attention to women entrepreneurs, opportunities for discussions on the needs of working women, share information about successful workplace policies, and raise awareness of the resources available for working women in their communities.

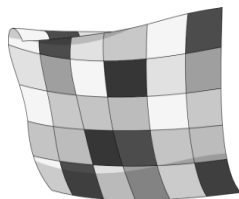
### Quilt Making Project

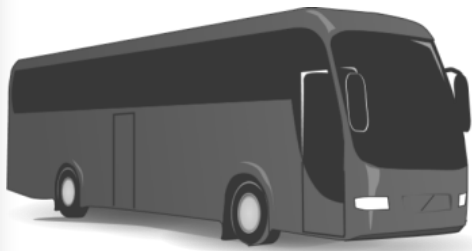

# WPEA 2015 Conference

## STATE NEWS

Seven BPW Legacy Partner states attended the 2015 WPEA in Greensboro, North Carolina on July 23-26, 2015.

Thursday, July 23rd, at a wine and cheese gathering, we participated in a ice breaker in which we all shared a bumper sticker, campaign pin, or slogan of interest.

On Friday we headed to downtown Greensboro. We went to the Civil Rights Museum for a very informative tour. On display was the original portion of the lunch counter and stools where the four students sat on Feb. 1, 1960, and it has never been moved from its original footprint. We met for dinner, introduction of the states members and a presentation of three YC speakers; our own KC Bailey gave her YC speech.

Saturday we attended the Bennett IV where NC's women's groups came together for an informational day of seminars. The seminars included:

- ERA - Status and update
- Latinas: Undocumented Immigrant Issues
- Pay Equity and Paid Leave
- Voting Rights and Challenges
- Reproductive Justice

ERA - Leona Phillips attended the presentation for the ERA. NC has a very strong campaign to get the ERA ratified for their state. There were several organizations making a presentation on the history of the ERA, what they are doing to bring awareness to the drive within their state, and how to contact your legislature. There was great discussion on the bills that are currently in Congress. NC currently have a resolution calling for the NC General Assembly to ratify the Equal Rights Amendment to the US Constitution

LATINAS - Karen Prelipp learned about the issues concerning the Latin American women. The lack of access to education and the language barriers offers many challenges for many urban and rural areas. Many remain undocumented and work paying taxes, while other families continue to be poverty stricken. If parents are deported the American born children are put into foster care.

VOTING - Karen McCready attended the seminar on the Monster Voting Law. Currently the North Caroline's voting laws are being challenged in the court system. This case has the potential to affect the voting laws in states with similar requirements. What needs to happen is accessible, fair, secure elections with a transparent and an accountable political system. Everyone should be concerned when your right to vote is being blocked.

REPRODUCTIVE JUSTICE - Liz Herrell learned that reproductive justice exists when all people have the social, political and economic power and resources to make healthy decisions about our gender, bodies and sexuality. Reproductive oppression is the controlling and regulation of our gender, bodies and sexuality. The discussions covered sterilization, criminalization of reproductive choices and actions as well as the lack of adequate choices.
