2024-2025 LEGISLATIVE PLATFORM

PREAMBLE: The Alice Paul Equal Rights Amendment shall stand first, foremost and above all other items which may appear on the Legislative Platform of this Federation until equal rights for women and men become guaranteed in the United States Constitution. THE ALICE PAUL EQUAL RIGHTS AMENDMENT: Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.

CIVIL RIGHTS: Actively work to pass legislation, which will ensure equal rights and remedies for women in all phases of their lives, including support of affirmative action programs; and eliminate all forms of harassment against individuals, and strengthen and improve voting registration, access and fair representation.

ECONOMIC EQUITY: Actively work to support equal educational opportunities; equal treatment for women in all areas of employment, including adequate retirement benefits, improved programs for women re-entering the workforce, and implementation of equal pay for work of comparable worth. Support legislation that promotes these goals.

DEPENDENT CARE: Actively work to strengthen and improve funding for enrichment programs, physical facilities and affordable quality dependent care of all ages regardless of limitations and abilities.

VICTIM RIGHTS: Actively work to strengthen and enforce legal protection for all individuals who are victims of violent acts including domestic and/or sexual violence (including coercive control); human trafficking; promote violence prevention programs; support services and facilities for survivors of this violence and the funding thereof; and support legislation that provides compensatory and punitive damage awards to victims.

HEALTH: Actively work to strengthen and enforce legal protection for full access to all health care services including mental health, Post-Traumatic Stress Disorder (PTSD), reproductive choice, funding for research into and protection for women's health care and educational programs concerning women's health issues. Actively promote access to mental and physical health care services.

POLICY ITEMS: Actively work for the election of and appointment to policy-making positions those who support the BPW Legislative Platform. Adopted May 2024

RESOLUTION IN SUPPORT OF OHIO SENATE BILL 231 REGARDING THE ESTABLISHMENT OF A SYSTEM TO REPORT WAGE DISCRIMINATION

Whereas, the Ohio Federation of Business and Professional Women (BPW/OHIO) has supported pay equity for women for over 100 years and advocates for women's rights in the workplace and fights against discrimination in the workplace, and

Whereas, wage disparity continues to exist in our society wherein women are paid substantially less than their male counterparts for comparable work, and

Whereas, wage disparity not only adversely impacts a woman's current earning power but also adversely impacts her future retirement income and/or social security benefits, and

Whereas, the State of Ohio does not have a system for individuals to report discrimination in the payment of wages by their employer, and

Whereas, many employees are hesitant to discuss or report wage disparity for fear of reprisals from their employer, and

Whereas, Ohio Senate Bill 231 known as the Pay Equity Hot-line will enable anonymous reporting of discriminatory practices by employers by creating a Pay Equity Hot-line so that Ohio employees can report the issues they have experienced in their employment. A state run Hot-line will hold employers accountable without employees fearing that they will lose their jobs or face retaliation by their employers

THEREFORE, BE IT RESOLVED THAT BPW/OHIO will work to actively support passage of Ohio Senate Bill 231, sponsored by State Senators Paula Hicks Hudson (D-Toledo) and Kent Smith (D-Fuelid)

Further, Be It Resolved that the members for the Ohio Federation of Business and Professional Women (BPW/OHIO) will educate themselves and others regarding this legislation;

It Is Further Resolved that the 2024-2025 BPW/Ohio Legislative Chair will monitor the status of this legislation as it moves through the Ohio Senate and House of Representatives and provide updates to the members of BPW/Ohio.

Further, Be It Also Resolved that the members of BPW/OHIO will demonstrate their support of Senate Bill 231 through letter writing, emails and telephone calls encouraging the passage of this important economic legislation by the Ohio Senate and House of Representatives.

RESOLUTION 2:

RESOLUTION IN SUPPORT OF OHIO SENATE BILL 232 REGARDING THE CREATION OF A PROGRAM TO EVALUATE AND DESIGNATE BUSINESSES AS FAIR PAYCHECK WORKPLACES

Whereas, the Ohio Federation of Business and Professional Women (BPW/OHIO) has supported pay equity for women for over 100 years and advocate for women's rights in the workplace, and

Whereas, wage disparity continues to exist in our society wherein women are paid substantially less than their male counterparts for comparable work, and

Whereas, in 2022, women earned an average of 82% of what men earned, and this wage disparity continued in 2023-2024, and

Whereas, wage disparity not only adversely impacts a woman's current earning power but also adversely impacts her future retirement income and/or social security benefits, and

Whereas, the State of Ohio does not have a system to encourage current and future employees to know whether or not an employer values their contributions in the workplace and compensates them appropriately, and

Whereas, the U. S. Chamber of Commerce recently reported that on average there is 62 workers to fill every 100 job openings indicating that we are in a tight labor market, therefore many employees have their choice of employers and are looking for employers who will compensate them appropriately, and

Whereas, in December 2022, the Harvard Business Review cited pay equity as a top to do for employers in an increasingly competitive labor market. Being able to identify employers who are paying competitive wages will help to close the wage gap and move us towards pay equity for all, and

Whereas, Ohio Senate Bill 232 known as the Fair Paycheck Workplace Act will create a program to evaluate and designate businesses as Fair Paycheck Workplaces recognizing their commitment and effort to pay their male and female workers equally.

THEREFORE, BE IT RESOLVED THAT BPW/OHIO will work to actively support passage of Ohio Senate Bill 232, sponsored by State Senators Paula Hicks Hudson (D-Toledo) and Kent Smith (D-Euclid)

Further, Be It Resolved that the members for the Ohio Federation of Business and Professional Women (BPW/OHIO) will educate themselves and others regarding this legislation;

It Is Further Resolved that the 2024-2025 BPW/Ohio Legislative Chair will monitor the status of this legislation as it moves through the Ohio Senate and House of Representatives and provide updates to the members of BPW/Ohio.

Further, Be It Also Resolved that the members of BPW/OHIO will demonstrate their support of Senate Bill 232 through letter writing, emails and telephone calls encouraging the passage of this important economic legislation by the Ohio Senate and House of Representatives.

This coming November, Ohio voters will determine who will represent them in the Ohio House of Representatives for the next two (2) years. All ninety-nine (99) House seats will be on the ballot. Additionally, there will be seventeen (17) seats in the Ohio State Senate up for election on November 5th, 2024.

BPW Ohio has a long history of supporting those candidates that support our Legislative Platform. We support those candidates with our votes, by working on their campaigns, by distributing literature about their positions and by personally donating to their campaigns.

However, these are not the only ways in which we can support candidates for State Offices (e.g., Members of Ohio's House of Representatives, Members of the Ohio Senate, Ohio Governor, Ohio Attorney General, Ohio Secretary of State, Treasurer of the State of Ohio. We can also support candidates who are running for any of these offices through our BPW Ohio PAC.

The BPW Ohio PAC is a Political Action Committee, and our purpose is to provide members of BPW Ohio with a mechanism to legally endorse and contribute financial support to candidates who support our Legislative Agenda.

As a member of BPW Ohio you can recommend candidates for endorsement and/or financial assistance from our BPW Ohio PAC. To start this process, identify those Candidates running for a State Office in your area that you believe supports BPW Ohio's Legislative Agenda. Do some research to find out where they stand on the issues that our important to our members. Typically, you can find some of this information by reviewing their campaign literature or website. If they are an incumbent, you can check out their voting record on issues that align with our Platform.

Once you have identified someone whom you believe supports our Legislative Platform, share that information with your BPW Local or Region so that they can decide if this is a candidate that they want to have our BPW/Ohio PAC endorse. To be considered for an endorsement or donation, the candidate must be nominated by either the BPW Ohio local organization or Region organization in their area.

Once the Local Organization or Region decides that they want to seek an endorsement and/or donation from the BPW Ohio PAC, then the Local Organization or Regional President should reach out to the Candidate to find out if they are interested in pursuing an endorsement or donation from our PAC. If the answer is yes, then the President should send the Candidate the following BPW/ Ohio PAC documents:

Presidents once you receive these items complete the BPW/Ohio PAC Nomination Form and send that form along with the documents received from the candidate to the BPW Ohio PAC Chair at the following address: Charlon K. Once I receive these documents, copies will be distributed to the BPW Ohio PAC Committee who will review them and decide if BPW/Ohio will be endorsing and/or making a donation to that Candidate.
